

How are we in Stanislaus County doing in terms of social distancing?

Three measurements of Social Distancing

1. Mobility
2. Non-Essential Visits
3. Encounter Density

- ✓ Per the data provided by Unacast and cuebiq., it is highly suggesting that Stanislaus County is no longer practicing 40 % reduction in social contacts anymore after May 20th.
- ✓ Mobility Index has gone up as much as before the Statewide Stay-at-Home order, but encounter density index has significantly gone down indicating that people are not gathering as much as before.
 - During the Labor Day weekend, there was a slight uptick in encounter density index.
- ✓ Stanislaus County is on [the widespread risk level](#), which is the most restrictive tier of [the State's Tier Framework](#).

Important Dates

- 03/19/20: Statewide Stay-at-Home Order
- 04/26/20: New Public Health Officer's Order – Open local parks and so on
- 05/20/20: Entered the Phase 2 of Reopening
- 06/18/20: Mandatory Facial Coverings in Public
- 07/02/20: State ordered the closure of bars and indoor operation (e.g., Restaurants, Wineries and Tasting Rooms, Family Entertainment Centers, Movie Theaters, Zoos and Museums, Cardrooms)
- 07/13/20: State extended the closure order of indoor operations to worship services, offices for non-critical sectors, hair salons and barbershops, malls.
- 08/31/20: State implemented a [new blueprint for reduction COVID-19](#) with revised criteria for loosening and tightening restrictions on activities.

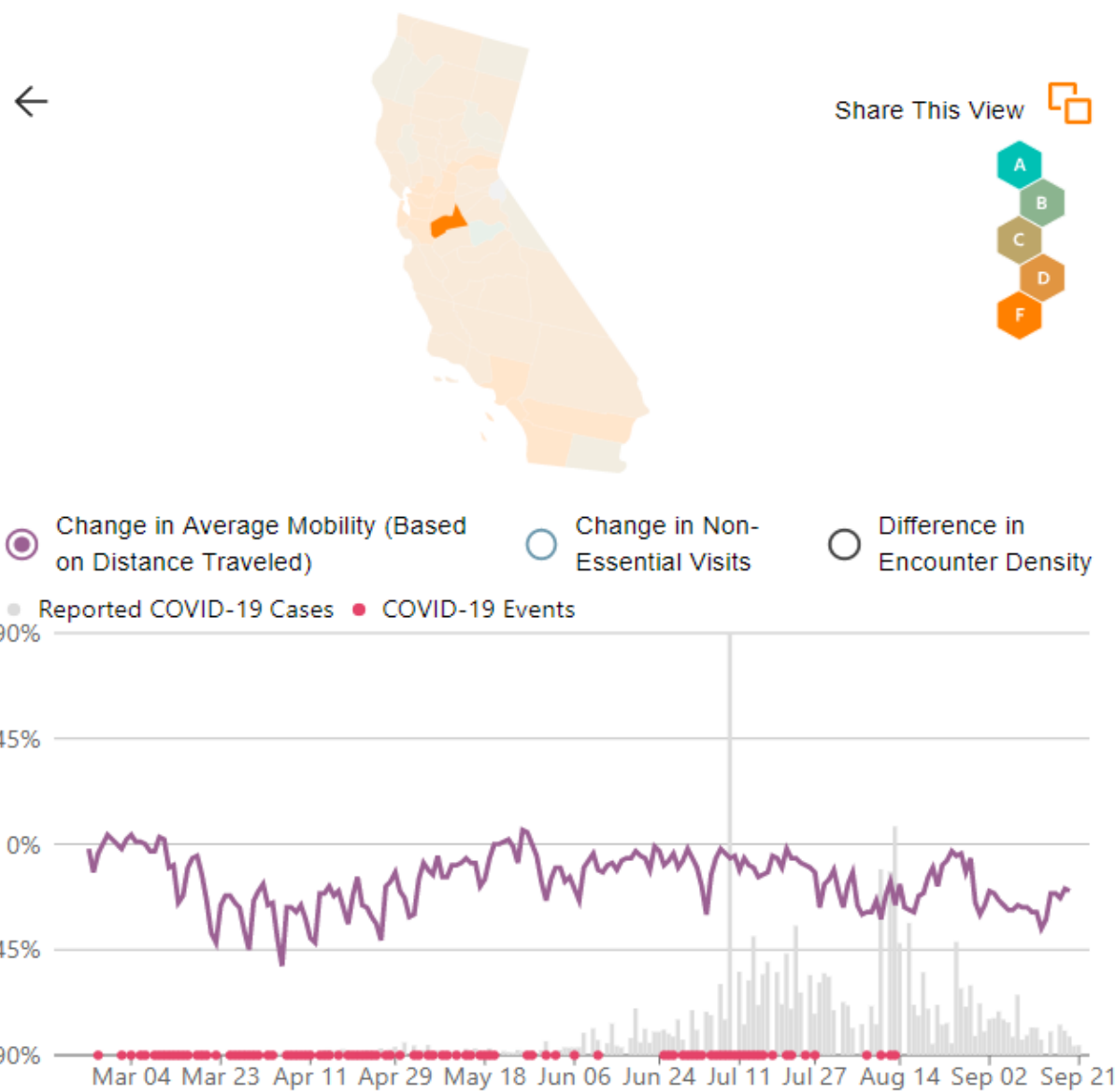

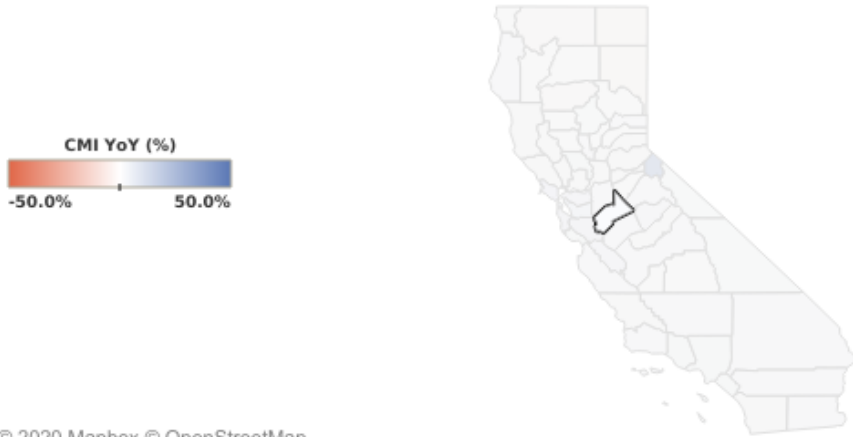

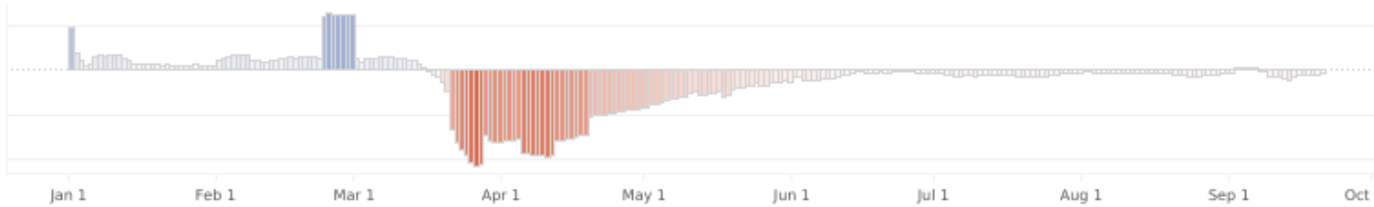

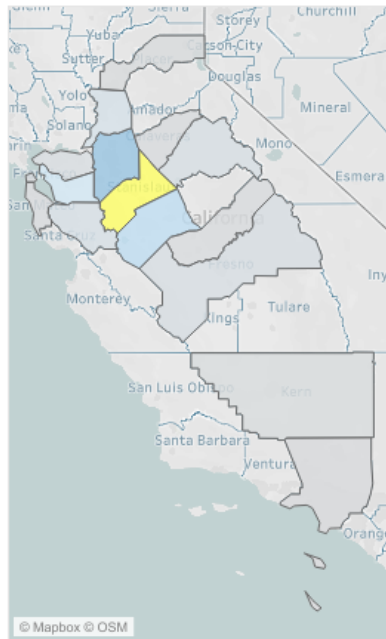

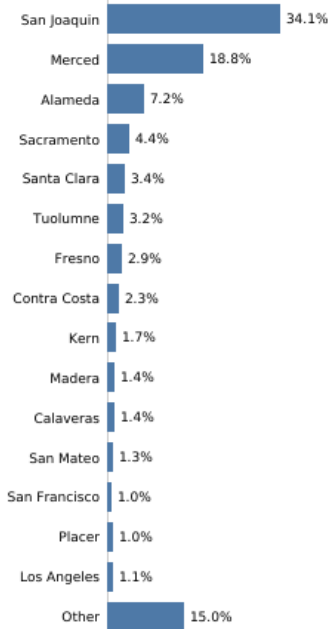

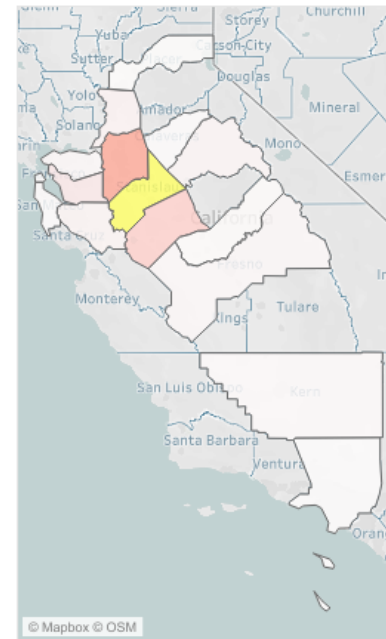
Arrival Rate to Stanislaus



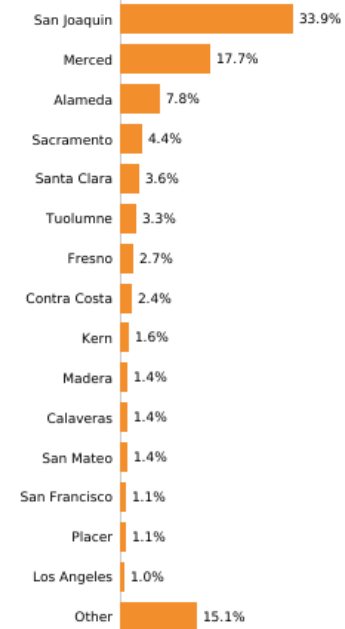
Top Origins



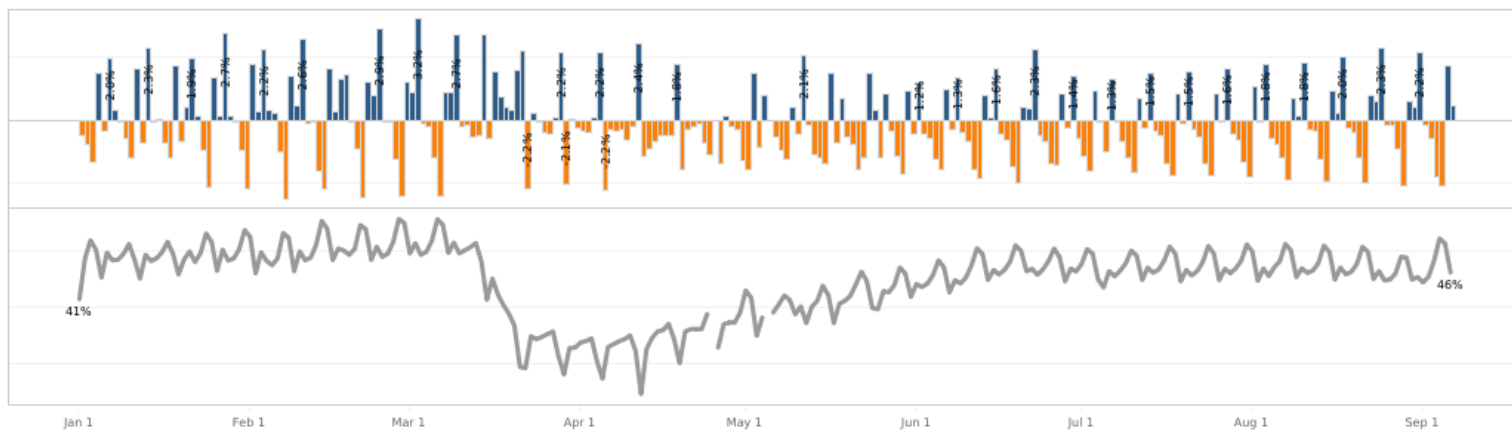
Departure Rate from Stanislaus

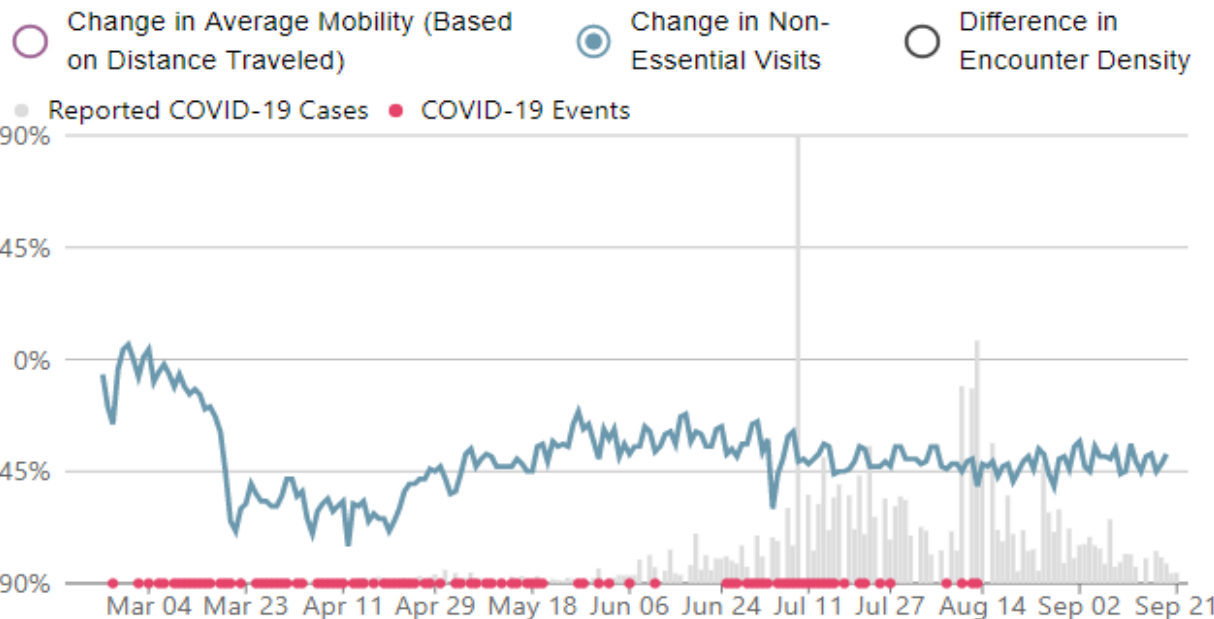

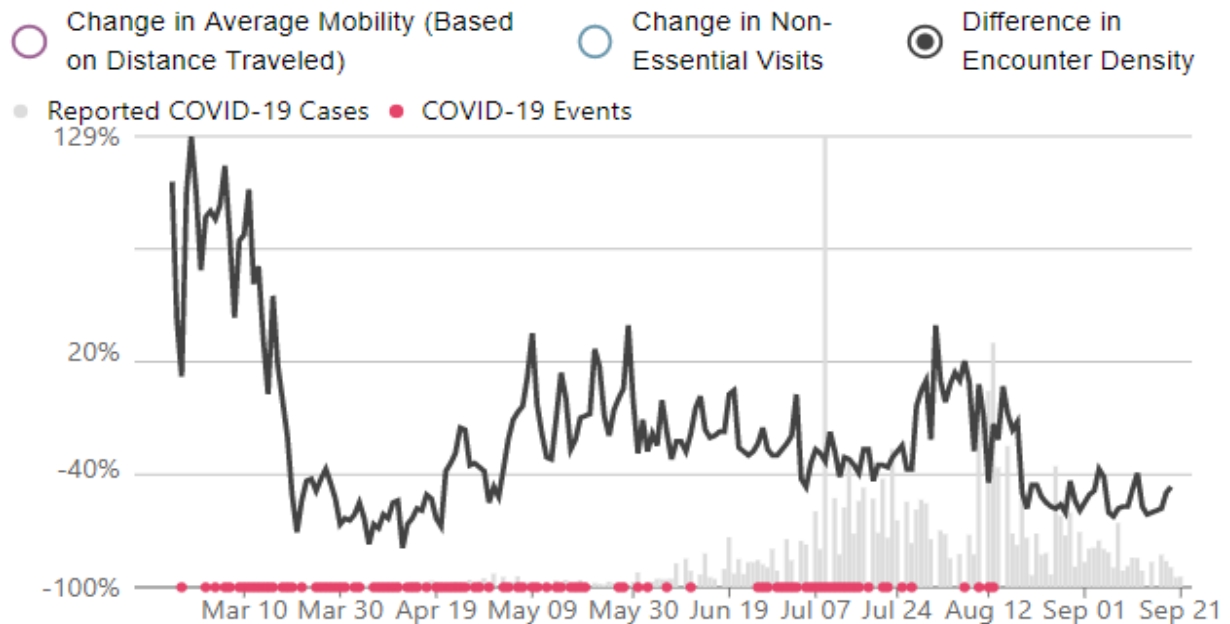

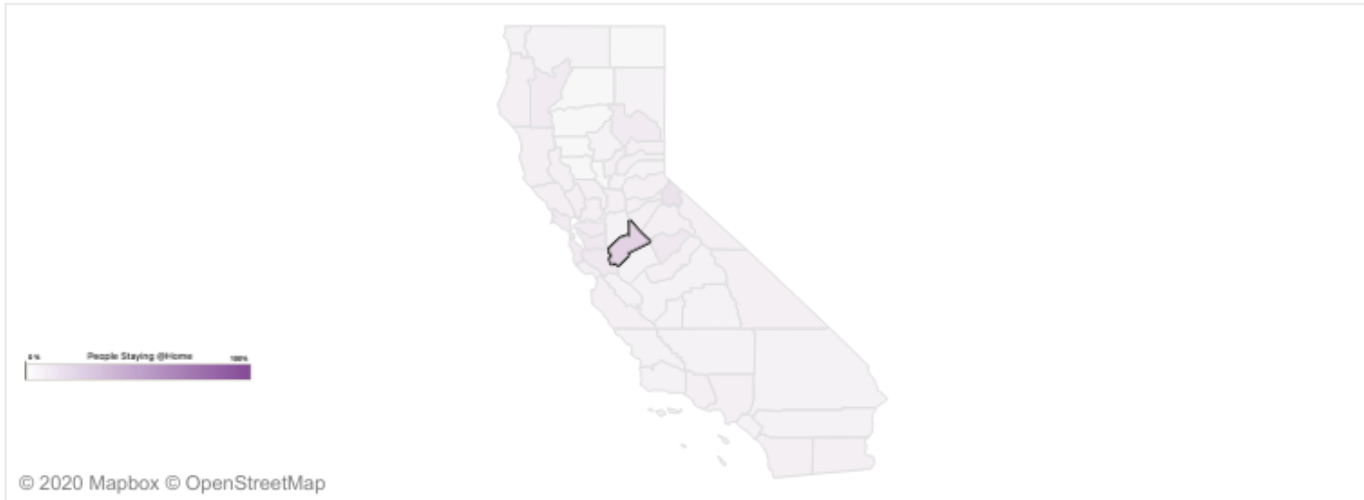

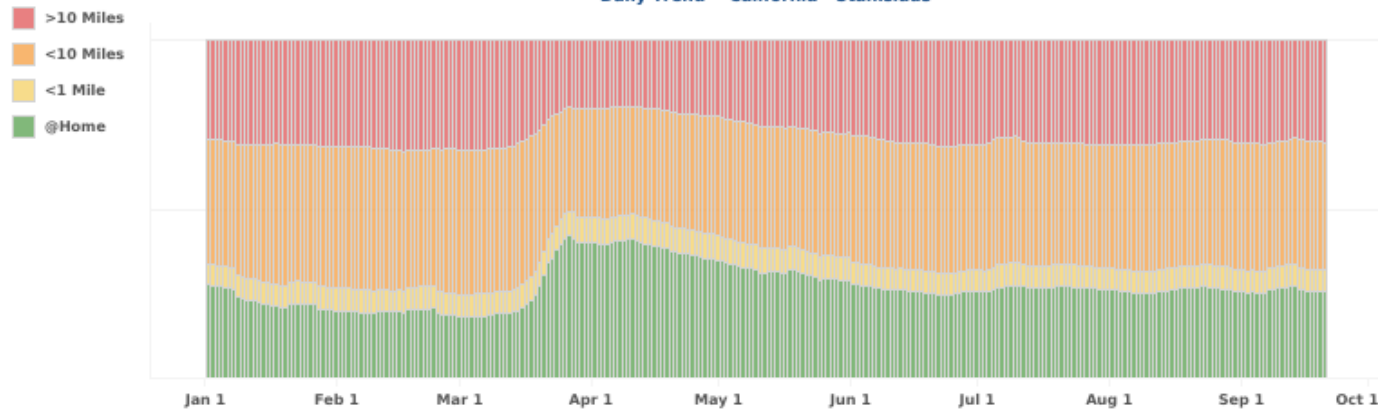

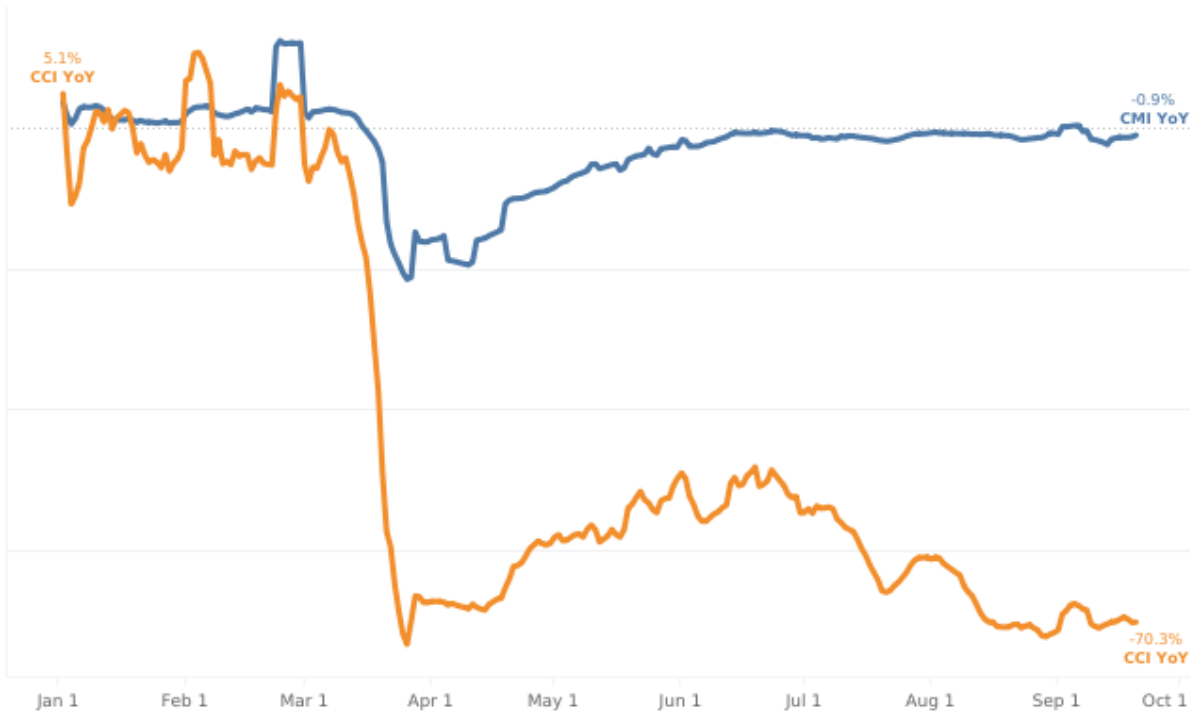
