Health Alert

Coronavirus Disease 2019 - Update 6

COVID-19 testing should be prioritized for medical evaluation of persons with symptoms of possible COVID-19 and for efforts by public health agencies and essential employers to prevent and control the spread of COVID-19.

County supported sample collection sites open to the public are running in Salida, West Modesto, and Turlock. Additionally, other healthcare organizations have COVID-19 sample collection sites either for their own patients or open to the general public.

Guidance for Stanislaus County Clinicians:

Individuals prioritized for COVID-19 testing (Viral (PCR or antigen)):

- Anyone with signs/symptoms of COVID-19 requiring hospitalization
- Symptomatic healthcare workers, first responders, and other social service employees; and asymptomatic, when needed to prevent disease transmission
- Symptomatic individuals age 65 and older; or symptomatic individuals of any age with chronic or other medical conditions that increase the risk of severe of COVID-19
- Individuals who are tested as part of disease control efforts in high-risk settings
- Symptomatic and asymptomatic residents and employees of congregate living facilities
- Symptomatic individuals in essential occupations, such as grocery store and food supply workers, utility workers, and public employees; and asymptomatic, when needed to prevent disease transmission
- Other individuals with symptoms consistent with COVID-19
